# **Artist Trading Card Swap** at May's meeting

Artist trading cards (ATC's) are miniature pieces of art that are traded around the world. Cards would be traded, one for one, among participating artists. If you bring 10 little paintings, potentially you can go home with 10 miniatures by your fellow NVWS members. The only official rule for ATCs is the size: 2.5" x 3.5. Cards may be cut by the artist or purchased at local art stores in precut, 140lb, 10 sheet packages. They are made from various papers including watercolor, acrylic, and illustration board and fit in to a standard trading card sleeve.

For this event miniature paintings would be originals. They should be created using water media which includes watercolors, acrylics, inks, gouache, casein, egg tempura, watercolor pencils and watercolor crayons. Collage materials would also be appropriate as long as they are created by the artist. Artists should include the following information on the back of the card: name, contact information (email or address), title of the piece, and number if it is part of a series.

- I understand that obtaining insurance coverage, if any, concerning loss or damage to the property shall be my sole responsibility and obligation.
